Dr Nick Armstrong Nick is a former HSE dental surgeon in Dublin, and a current IDA Patient Safety Committee member. He graduated from Trinity College Dublin in 1974 and worked in private practice in the UK for 16 years.



Prof. Avijit Banerjee Avijit qualified in dentistry from Guy's Hospital (London) in 1993. After obtaining his FDSRCS (Eng), he received his Masters in Mineralised Tissue Biology, and a Doctorate in Cariology. He is currently Chair in Cariology & Operative Dentistry, as well as Director of Integrated Clinical Care & Conservative Dentistry, at the King's College London Dental Institute at Guy's Hospital.



Dr Andrew Bolas Andrew received his BDA from Queen's University in 1991, his FFDRCSI in oral surgery in 1994, his FDSRCSI oral surgery and oral medicine in 1995 and an MSc in dental radiology in 2000. He moved to Sligo in 1997 and is employed with the HSE. He is a past President of the IDA.



Dr Emma Corrigan Emma is a HSE dentist based in the Merchant Quay services for the homeless in Dublin city.



Dr Edward Cotter Edward graduated from TCD in 1988. He gained graduate training in prosthodontics at the University of Iowa, a Fellowship in Prosthodontics in Iowa City, and a Fellowship in maxillofacial prosthetics and dental oncology in Houston, Texas.



Dr Dan Counihan Dan qualified in 1985 from UCC and he received his orthodontic qualification in 1983. After some time working in the UK, Dan returned to UCC to work in the Orthodontic Unit of Cork Dental School and Hospital. He set up a practice in Tralee in 1980, where he still practises today.



**Dr Alison Dougall** Alison is Consultant in Medically Compromised Patients at Dublin **Dental University** Hospital. She qualified in Leeds and trained in special needs dentistry at the Eastman in London. Her areas of particular interest include inherited coagulation disorders, special care and sedation, and treatment of patients with challenging behaviour.



**Dr Martin Foster** Martin gualified in 1986 and worked in general practice before moving into the Community Dental Service. He has a Master's in Public Health, Diploma in Health Service Management, and is registered as a Specialist in Paediatric Dentistry. Martin began his career at Dental Protection as a part-time Associate Dento-Legal Adviser before taking up his current position as a Dento-legal Adviser in 2011.



**Dr Ailbhe** McDonald Having graduated from the Dublin Dental Hospital, Ailbhe is now Senior Lecturer/Honorary Consultant in **Restorative Dentistry** at the UCL Eastman Dental Institute and Dental Hospital. She was appointed as Academic Head of Prosthodontics in 2009.
