Dr. Marga Ree DDS, MSc. Endodontist graduated from the University of Amsterdam in 1979. In 1998 she entered a postgraduate programme in endodontics, which she completed in 2001 with a Master of Science degree. Since that time she has lectured widely and taught hands-on courses throughout the Netherlands and abroad. She is the primary author of several articles published in national and international journals and has contributed to several books on endodontics and restorative dentistry. Since 1980, she has had a private practice in Purmerend, which for the past fourteen years has been dedicated to endodontics.

Dilemmas in Diagnosis and Treatment Planning: Should we do Endodontic Treatment or not?

This is an interactive session that will cover diagnostic dilemmas in the management of lesions of endodontic and periodontal origin, traumatic dental injuries, calcified canals and root resorption.

The Endodontic-Restorative Interface.

Long-term success of endodontic treatment is highly dependent on the restorative treatment that follows. This presentation will focus on the interaction between irrigation solutions and dentin bonding, the rationale for and against the use of posts and the selection and use of composite core materials. Several cases will illustrate the various current clinical techniques.

Dilemmas in Treatment Planning: Retreatment versus Implant Placement.

This presentation will address the decision making process related to nonsurgical endodontics and implants. With the emergence of implants into the mainstream of dentistry, there has been more emphasis on long-term outcomes and on evaluating the restorability of teeth prior to endodontic treatment. Teeth that might have received endodontic treatment in the past are now extracted and replaced with implant-supported prostheses if they are marginally restorable or it makes more sense in the overall treatment plan.

Dr. Paddy Crotty, BDentSc, FDSRCS (Edin.) FFDRCSI, FICD is a family dentist who has developed an expertise in general restorative dentistry with a particular skill in conservative and healthy ways of creating, transforming and reviving smiles without the need for cutting back the teeth. Having graduated from Trinity College Dublin, Dr Crotty obtained a fellowship in restorative dentistry from the Royal College of Surgeons in Edinburgh. He was later honoured with fellowships of the Royal College of Surgeons in Ireland and the International College of Dentists. He has been a part time lecturer in Trinity College for many years and has lectured extensively on cosmetic dentistry and dental bonding in Ireland and the UK.

Dr. Crotty will share his expertise in the area of posterior composite restorations, in particular how modern materials function in the posterior regions of the mouth. He will demonstrate the use of composite material in conservative way to prevent the need for more extensive restorations.

Professor Marie Cassidy, State Pathologist MB ChB Glasgow is currently State Pathologist in Ireland, involved in the investigation of suspicious Deaths and Homicides. She has been a Forensic Pathologist for 27 years and prior to her appointment in 1998 she worked in the Forensic Department at Glasgow University. She is Professor of Forensic Medicine in the Royal College of Surgeons of Ireland, which involves teaching Forensic Medicine to medical students.

As part of her forensic work she has been involved with the U.N. since the mid 1990's. She has travelled to Bosnia on several occasions, as well as to Croatia and latterly to Sierra Leone as part of a team involved in the investigation of war crimes, in particular the examination of bodies from mass graves.

She will lecture on the important role dentists can play in area of forensic pathology.
